## Managed Investment Trust Notice for Custodians and other Intermediary Investors in 360 Capital Enhanced Income Fund

360 Capital FM Limited as responsible entity of the 360 Capital Enhanced Income Fund (TCF) considers the Fund is a managed investment trust for the purposes of Subdivision 12-H of the Taxation Administration Act 1953 and applies the Attribution Managed Investment Trust (AMIT) regime in respect of the financial year ending 30 June 2023.

The AMIT information presented below is relevant for non-resident investors and custodians of non-resident investors that are obliged to deduct withholding tax (WHT) on payments made to non-resident investors.

Set out below are the estimated taxable components of the **June 2023 monthly distribution** to be made on or about 7 July 2023. These components are provided solely for the purposes of Subdivision 12-H of the Taxation Administration Act 1953 (Cth) and should not be used for any other purpose. The components are **estimates only** - the actual components for the income year ending 30 June 2023 will be advised in August 2023.
