## **Managed Investment Trust Notice for Custodians and other Intermediary Investors in 360 Capital Mortgage REIT**

360 Capital FM Limited as responsible entity of the 360 Capital Mortgage REIT (TCF) considers the Fund is a withholding managed investment trust for the purposes of Subdivision 12-H of the Taxation Administration Act 1953 and applies the Attribution Managed Investment Trust (AMIT) regime in respect of the financial year ending 30 June 2025.

Set out below are the estimated taxable components of the **May 2025 monthly distribution of 6.0 cents per unit** to be made on or about 6 June 2025. These components are provided solely for the purposes of MIT non-resident withholding tax under Subdivision 12-H and 12A-B of Schedule 1 of the Taxation Administration Act 1953, and non-resident interest withholding tax under Subdivision 12-F of Schedule 1 of the Taxation Administration Act 1953 and should not be used for any other purpose.

The components are **estimates only** - the actual components for the income year ending 30 June 2025 will be advised in August 2025.

The fund payment is **nil** cents per unit in respect of the income year ending 30 June 2025.

The fund payment has been determined in accordance with Subdivision 12A-B of Schedule 1 to the Taxation Administration Act 1953, being the amount from which an amount would have been required to be withheld under Subdivision 12-H of Schedule 1 to the Taxation Administration Act 1953 if the payment had been made to an entity covered by section 12-410 of that Schedule.

**Australian resident Unitholders should not rely on this notice for the purposes of completing their income tax returns.** Details of the full year components of distributions will be provided in the AMIT Member Annual (AMMA) Statement, which will be sent to Unitholders in August 2025.
